## STUDENT IMPORTANT DATES TO REMEMBER

### Spring 2021 (Regular Session)

Classes begin .....January 19, 2021  
Drop/Add.....January 19-20, 2021  
Charges will be incurred after the NO Show Date .....February 4, 2021  
(A student is considered a “No Show” if there is no documentable engagement with the course content within the timeframe allowed.)

**Your MDCC instructor will designate weekly attendance markers. You are allowed 2 absences (missing 2 attendance markers) in the regular session classes; therefore, on your 3<sup>rd</sup> absence you will be cut from the course. Be sure you understand the instructor’s policy if taking a course from another school.**

Mid-term exam proctored dates .....February 25, March 1-4, 2021
