Credentialing Parameters for MDCC Disciplines

Degrees and course work must be obtained from institutions that are nationally accredited colleges or universities. Any deviation from this practice must be approved by the President of the College or his designee in conjunction with the Vice President of Instruction and Human Resources. International credentials must be assessed as equivalent academic preparation by an approved evaluation service.

Course work submitted by the faculty applicant as graduate credit must be clearly designated by the granting institution as part of a graduate program, or formally validated by the granting institution as graduate level study. Official documentation must be provided by the granting institution.
